A total of 179,771 shares were repurchased by our company on 23.05.2023 from the price range of 12.27 – 12.67 TL (weighted average 12.49 TL).

The total number of repurchased shares was 2,000,000 and the ratio of the repurchased shares to the capital was 0.762%.
