### **Additional Explanations**

Within the scope of the share repurchase transactions initiated with the decision of our Company's Board of Directors dated 25.06.2024;

MHRGY shares with a total nominal value of TL 200,000 were repurchased by our Company on 13.08.2024 at a price range of TL 4.53 - TL 4.54 (weighted average TL 4.535) per share in Borsa Istanbul.

As a result of these transactions, the total value of the repurchased shares as of 28.06.2024 was TL 47,075,000 and the ratio of these shares to the capital was realized as 1.13%.
