During the sale of non-performing loans conducted on December 13th, 2024, by Garanti Faktoring A.Ş., GSD Varlık Yönetim A.Ş., a wholly-owned subsidiary of our company, successfully won the tender by submitting the highest bid for commercial portfolios put up for sale, with a total principal amount of 88.9 million TL. A total of 8 asset management companies participated in this tender.
