Explanations	

Within the scope of the "Share Purchase Agreement" signed on 14.06.2024, Lydia Holding A.Ş. and other buyers—Lydia Yeşil Enerji Kaynakları A.Ş., 1000 Yatırımlar Holding A.Ş., Bulls Yatırım Holding A.Ş., Bulls Yatırım Menkul Değerler A.Ş., and Re-Pie Portföy Yönetimi A.Ş. (on behalf of clients receiving Special Portfolio Management Services)—purchased shares of Ufuk Yatırım Yönetim ve Gayrimenkul A.Ş. (Ufuk Yatırım) with a nominal value of 43,579,642.10 TL from Yıldız Holding A.Ş. on 09.12.2024. A total of 48,000,000 USD was paid to Yıldız Holding A.Ş. for these shares. As a result of this transaction, Lydia Holding A.Ş.'s share in Ufuk Yatırım's capital has reached 60.17%.

Pursuant to the "Share Purchase Agreement" dated 14.06.2024, Lydia Holding A.Ş. has become obliged to make a Mandatory Share Purchase Offer ("Share Purchase Offer") under the Capital Markets Board of Türkiye's ("CMB") Communiqué on Tender Offers (II-26.1).

The information document regarding the Share Purchase Offer ("Share Purchase Offer Information Document") was approved by the CMB on 06.02.2025, and the share purchase offer price was determined as 280.21 TL.

In accordance with Article 17/1 of the CMB Communiqué on Tender Offers, if the actual share purchase offer does not commence within two months from the date the mandatory share purchase offer obligation arose (09.12.2024), interest calculated at 50% above the annual Turkish Lira Overnight Reference Rate (TLREF) will be added to the share purchase offer price for each day exceeding the deadline. Interest calculation will be based on simple interest. Since the last day to

initiate the share purchase offer (09.02.2025) falls on a weekend, the deadline has been extended to the next business day, 10.02.2025, per the CMB's offical letter dated 07.02.2025. Accordingly, with the addition of 50% above the TLREF interest rate announced by Borsa Istanbul on 07.02.2025, the share purchase offer price has been updated to 280.72 TL.

In this context, the Mandatory Tender Offer transactions will be carried out through Bulls Yatırım Menkul Değerler A.Ş. between 11.02.2025 and 24.02.2025, and the Mandatory Share Tender Offer Information Form, Share Offer Request Form and Information Document are attached.

The Share Purchase Offer Information Document will be published on www.ufukyyg.com.tr and www.bullsyatirim.com following this Public Disclosure Platform (KAP) announcement.
