Additional Explanations

Pursuant to the review of the Consolidated Financial Statements for the year 2024, prepared in accordance with the Turkish Accounting Standards / Turkish Financial Reporting Standards, it has been resolved unanimously by the attendants to propose to the General Assembly to distribute the profit as follows:

- Distribution of a cash dividend in an amount of TL 2.87 per 1 TL nominal share, with a payout ratio of 80.21% based on an underlying net income (net income excluding any exceptional items) of TL 4,225,991,691.35
- Total of TL 3,389,667,935.63 dividend (Gross 287.00%, Net 243.95%) to be distributed entirely from the retained earnings in cash to the shareholders who are representing the TL 1,181,068,967.12 capital.
