Söz konusu finansal tablolar ile Hun Yenilenebilir Enerji Üretim A.Ş.'nin Vergi Usul Kanunu (VUK) hükümlerine uygun olarak tutulan kayıtlara göre oluşan mali tablolarının incelenmesi sonucunda;
