In the non-performing loans sale conducted on April 28th, 2025 by QNB BANK A.Ş., our company successfully secured the tender by submitting the highest bid for 4 Retail and 2 SME-Corporate portfolios with a total principal amount of 1 billion 420.4 million TL out of 12 Retail and 2 SME-Corporate portfolios put up for sale. 19 asset management companies joined the tender process.

It is important to note that the finalization of the tender results is subject to the approval of the Board of Directors of the bank. Once the approval is obtained, the subsequent phases, including contract execution and the transfer of the loans associated with the sale process, will commence accordingly.
