On July 24, 2025, a partnership agreement was signed between our company and ClimeCo İnteraktif Danışmanlık ve Ticaret A.Ş. to establish a collaboration in the fields of carbon markets and sustainability services.

Within this scope, both parties have mutually agreed that ClimeCo will exclusively utilize ATP GreenX's software and digital infrastructure for the trading of carbon credits and environmental products carried out through our ATP GreenX digital carbon market platform.

Additionally, the parties have agreed to refer organizations seeking services such as environmental, social, and governance (ESG) consultancy, carbon/water footprint assessments, and sustainability reporting in compliance with TSRS and CBAM (Carbon Border Adjustment Mechanism) to ClimeCo.

This partnership has been structured to provide integrated, digital, and expertise-driven solutions to carbon market participants in Turkey and abroad. The agreement is valid for one year and will be automatically renewed if certain conditions are met.
