Out of the shares of Ral Yatırım Holding A.Ş. ("RALYH") that had been temporarily and gratuitously transferred to our Company by our shareholder Mr. Rıza KANDEMİR within the scope of our Company's financing and collateral transactions, shares with a nominal value of TL 1,000,000 were transferred back to Mr. Rıza KANDEMİR free of charge on 25.12.2025.

Following this transfer, the total nominal value of the shares held by Mr. Rıza KANDEMİR has reached TL 121,661,918.92, corresponding to a shareholding ratio of 36.54% in the Company's capital. After the transfer, the total nominal value of the shares held by our Company amounts to TL 1,527,901, including the shares acquired within the scope of the Board of Directors' resolution dated 21.07.2023 regarding the share buyback program, corresponding to a shareholding ratio of 0.46% in the Company's capital.
