According to the notification received by our Company, it has been understood that one of our shareholders, Mr. Rıza Kandemir, has temporarily transferred shares with a nominal value of TRY 1,000,000, corresponding to 0.3% of our Company's capital, to our Company for financing/collateral purposes.

Following the said transfer transaction, the total nominal value of the shares held by Mr. Rıza Kandemir has reached TRY 120,661,918.92, corresponding to a shareholding ratio of 36.23% in the Company's capital. Following the transfer transaction, the total nominal value of the shares held by our Company has reached TRY 2,527,901, including the shares acquired within the scope of the Board of Directors' resolution dated 21.07.2023 regarding the share buyback program, corresponding to a shareholding ratio of 0.76% in the Company's capital.
