Reference: Public disclosure dated 12.02.2026 Public disclosure dated 13.02.2026 Certificate for the issuance of Additional Tier I notes for a total amount of USD 600.000.000 has been approved by the Capital Markets Board. In this regard, additional Tier 1 notes have the call option subject to the prior approval of the BRSB on all the option dates mentioned below. The first call option could be exercised on the 5th Year after the issuance, on any date from 19 February 2031 to 19 August 2031. In case this option is not exercised, the notes will be callable on each semi-annual coupon payment dates. Coupon rate of AT1 notes has been set at 7,950% and issuance of the notes will be completed on 19 February 2026. Additional Tier 1 Notes are perpetual. However, the maturity date is written as 19.08.2031 in order to register the notes in the Central Securities Depository's (MKK) system. In case of contradiction between the Turkish and English versions of this public disclosure, the Turkish version shall prevail.
