Pursuant to the scope of the share repurchase transactions initiated by the Board of Directors' decision of our Company dated on 20.03.2025;

With a price range of 5.15 TL – 5.20 TL (weighted average 5.1995 TL) summing up to GSDHO shares with nominal value of 12,379,957 TL were repurchased on 14.07.2026.

The total value of the shares repurchased as of 14.07.2026, including the shares which have not yet been disposed of from the shares acquired by our Company through the last buyback program, is 136,605,770.2 TL and the ratio of these shares to the capital is 13.6606%.
