Explanations

In accordance with the resolution of our Company's Board of Directors dated 16.07.2026;

The recent upward trend in energy costs, the increase in raw material prices, and the fluctuations observed in finished product sales prices with respect to our Paper Factory operating in the Konya Ereğli Organized Industrial Zone have been evaluated. Taking into account market conditions and cost balances, it has been decided to temporarily suspend production activities at our factory for approximately 3 months, effective as of 16.07.2026.

During this temporary suspension period, efforts will be focused on commissioning the Cogeneration Facility, the installation of which is ongoing within our factory. Following the commissioning of this facility, production at our factory will resume in light of the operational improvement and cost advantages to be achieved in electricity and steam supply.

Significant developments regarding the process, as well as the date of resumption of production, will be communicated to the public and our investors in a timely manner.
