Şirketimizin 1.000.000.000 TL tutarındaki ihraç tavanı içerisinde kalmak kaydıyla yurt içinde halka arz edilmeksizin ihraç edilecek borçlanma araçlarına ilişkin ihraç belgesi, Sermaye Piyasası Kurulu'nun 01.07.2026 tarih ve 41/1225 sayılı kararı ile onaylanmıştır. Bu kapsamda Alnus Yatırım Menkul Değerler A.Ş.'nin 1.000.000.000 TL ihraç tavanı içerisinde 77.000.000 TL nominal değerli 182 gün vadeli finansman bonosunun 13.07.2026 tarihinde nitelikli yatırımcılara satışı gerçekleşmiştir.
