Additional Explanations

The share buyback program initiated by the decision of the Board of Directors dated July 31, 2026 has been completed. The purchase transactions made during the 1-month period of the Buy-back Program are shown in the table. Within this framework;

As a result of the initiated share buyback program, our Company repurchased a total of TRY 1.800.452 nominal value shares on the Istanbul Stock Exchange (BIST) between August 4, 2026 and August 31, 2026 at an average price of TRY 9,6909. The maximum price paid for shares repurchased during this process was TRY 10,7 per share. The total amount paid for the share buyback is TRY 17.447.924 from company resources and within the scope of the mentioned buyback program the ratio of TEZOL shares owned by our Company to the capital is 0,36% as of August 31, 2026.
