On 04.09.2026, our Company repurchased SUWEN shares with a total nominal value of TRY 746,859 on Borsa İstanbul at a price range of TRY 6.70 – TRY 6.82 per share (weighted average TRY 6.767). (Ratio to the Company's share capital: 0.13337%).

As a result of this transaction, the total nominal value of the repurchased shares has reached TRY 20,746,859, corresponding to 3.70480% of the Company's share capital.
