On September 18, 2026, MAVI B Group shares with TRY 300,000 nominal value were repurchased within a price range of TRY 36.20 – TRY 37.44 (average TRY 36.7280) per share per share on Borsa Istanbul by our company.

Following this transaction, the total number of B group shares repurchased to date has reached 14,812,000 corresponding to approximately 1.86% of the share capital.
