We had announced the temporary closing of all our retail and franchise stores in Turkey, and our retail stores in Germany and Canada within the public disclosure dated 18.03.2020.

In addition to these precautions, we have decided to temporarily close our stores in Russia in line with the Russian government decisions and to suspend our online store mavi.com operations in Turkey.
